WHEREAS, the Landmarks Preservation Commission filed with the Council on March 26, 2008 a copy of its designation dated March 18, 2008 (the "Designation"), of the Free Public Baths of the City of New York, East 11th Street Bath, located at 538 East 11th Street, Community District 3, Borough of Manhattan, as a landmark and Block 404, Lot 23, as its landmark site pursuant to Section 3020 of the New York City Charter;

WHEREAS, the Designation is subject to review by the Council pursuant to Section 3020 of the City Charter;

WHEREAS, the City Planning Commission submitted to the Council on May 12, 2008 its report on the Designation dated May 7, 2008 (the "Report");

WHEREAS, upon due notice, the Council held a public hearing on the Designation on June 2, 2008; and

WHEREAS, the Council has considered the land use implications and other policy issues relating to the Designation;
