WHEREAS, the Landmarks Preservation Commission filed with the Council on March 26, 2008 a copy of its designation dated March 18, 2008 (the "Designation"), of the (Former) Congregation Beth Hamedrash Hagadol Anshe Ungurn, located at 242 East 7<sup>th</sup> Street, Community District 3, Borough of Manhattan, as a landmark and Block 376, Lot 13, as its landmark site pursuant to Section 3020 of the New York City Charter;

WHEREAS, the Designation is subject to review by the Council pursuant to Section 3020 of the City Charter;

WHEREAS, the City Planning Commission submitted to the Council on May 12, 2008 its report on the Designation dated May 7, 2008 (the "Report");
