**Whereas**, bills have been introduced in the New York State Legislature by Senator Golden, S. 7229-A, and Assembly Member Bing, A. 10233-A, "AN ACT to amend the vehicle and traffic law and the public officers law, in relation to establishing in a city with a population of one million or more a bus rapid transit and bus mobility demonstration program to enforce restrictions on the use of bus lanes by means of bus lane photo devices; and providing for the repeal of such provisions upon expiration thereof"; and
