WHEREAS, the City Planning Commission filed with the Council on November 20, 2008 its decision dated November 19, 2008 (the "Decision") on the application submitted pursuant to Section 197-c of the New York City Charter by the Department of Housing Preservation and Development for property located at 148 West 143<sup>rd</sup> Street (Block 2011, Lot 57), Community District 10, Borough of Manhattan (the "Site"), (ULURP No. C 080502 PQM) (the "Application");

WHEREAS, the Application is related to ULURP Application Number C 080501 HAM (L.U. No. 887), a UDAAP designation and project approval, and disposition of city owned property;

WHEREAS, the Decision is subject to review and action by the Council pursuant to Section 197-d(b)(2) and (3) of the City Charter;

WHEREAS, upon due notice, the Council held a public hearing on the Decision and Application on December 15, 2008;
