WHEREAS, the Landmarks Preservation Commission filed with the Council on November 25, 2008 a copy of its designation dated November 18, 2008 (the "Designation"), of the Baumann Brothers Furniture and Carpets Store located at 22-26 East 14th Street aka 19-25 East 13th Street, Community District 2, Borough of Manhattan, as a landmark and Block 571, Lots 1101 and 1102, as its landmark site pursuant to Section 3020 of the New York City Charter;
