Resolution approving the site plan for a 560-Seat Primary School Facility to be located at 578-590 Avenue of the Americas (Tax Block 818, Tax Lot 3), Borough of Manhattan (Non-ULURP No. 20095161 SCM; Preconsidered L.U. No. 979).

WHEREAS, the New York City School Construction Authority submitted to the Council on February 4, 2009, a site plan pursuant to Section 1732 of the New York State Public Authorities Law for a new 560-Seat Primary School Facility in the building currently occupied by the New York Foundling Hospital located at 578-590 Avenue of the Americas (Tax Block 818, Tax Lot 3), Community Board No. 5, Borough of Manhattan, Community School District No. 2 (the "Site Plan");

WHEREAS, the Site Plan is subject to review and action by the Council pursuant to Section 1732 of the New York State Public Authorities Law;

WHEREAS, upon due notice, the Council held a public hearing on the Site Plan on February 9, 2009;

WHEREAS, the Council has considered the relevant environmental issues and the Negative Declaration issued on February 2, 2009 (SEQR Project Number 09-003); and

WHEREAS, the Council has considered the land use implications and other policy issues relating to the Site Plan;

RESOLVED:

The Council finds that the action described herein will have no significant effect on the environment.

Pursuant to Section 1732 of the Public Authorities Law, the Council approves the Site Plan.
