Resolution disapproving the decision of the City Planning Commission on an application submitted by the Department of Housing Preservation and Development, ULURP No. C 020591 HAM, approving the designation of 225, 227, 229, 231/33, 235/37, and 241 East 118th Street (Block 1783/Lots 12-16, 117, and 18), Manhattan, as an Urban Development Action Area, approving the project for the area as an Urban Development Action Area Project, and approving the disposition of such property to be selected by the Department of Housing Preservation and Development (L.U. No. 213; C 020591 HAM).

WHEREAS, the City Planning Commission filed with the Council on September 25, 2002 its decision dated September 18, 2002 (the "Decision"), on the application submitted by the Department of Housing Preservation and Development pursuant to Section 197-c of the New York City Charter and Article 16 of the General Municipal Law of New York State regarding:

- a) the designation of 225, 227, 229, 231/33, 235/37, and 241 East 118th Street (Block 1783/Lots 12-16, 117, and 18), as an Urban Development Action Area (the "Area");
- b) an Urban Development Action Area Project for such area (the "Project"); and

pursuant to Section 197-c of the New York City Charter for the disposition of such property to a developer to be selected by the Department of Housing Preservation and Development to facilitate the construction of a six-story elevator building tentatively known as Greater Emmanuel LESC Residence, with 72 units of housing for formerly homeless, low-income persons with disabilities and one superintendent's unit, Community District 11, Borough of Manhattan (the "Disposition") (ULURP No. C 020591 HAM) (the "Application");
