A Local Law to amend the administrative code of the city of New York, in relation to the sufficiency of proof of domestic partnership as evidence of the existence of a family unit for purposes of applications for shelter provided by the department of homeless services.

Be it enacted by the Council as follows:

Section 1. Chapter 3 of title 21 of the administrative code of the city of New York is hereby amended to add a new section 21

-316 to read as follows:

**§21-316. Proof of domestic partnership recognized as evidence of the existence of a family unit.** Two adults who can demonstrate that they have a valid certificate of domestic partnership registration issued under section 3-244 of the administrative code of the city of new york or a relationship recognized as a domestic partnership under section 3-245 of the administrative code of the city of new york, shall be considered a family unit for purposes of determining eligibility for shelter.

§2. This local law shall take effect 3 upon enactment.
