WHEREAS, the Department of Consumer Affairs filed with the Council on September 19, 2008 its approval dated September 18, 2008 of the petition of Delano Café Corp., d/b/a delano Café · Lounge, for a revocable consent to establish, maintain and operate an unenclosed sidewalk café located at 29-02A Francis Lewis Boulevard, Community District 7, Borough of Queens (the "Petition"), pursuant to Section 20-226 of the New York City Administrative Code (the "Administrative Code");
