WHEREAS, the Landmarks Preservation Commission filed with the Council on November 20, 2020 a copy of its designation report dated November 10, 2020 (the "Designation"), designating the Angel Guardian Home located at 6301 12th Avenue (aka 6301-6323 12th Avenue, 1202-1216 63rd Street, and 1201-1215 64th Street), Community District 10, Borough of Brooklyn, as a landmark and Tax Map Block 5739, p/o Lot 1, as its landmark site pursuant to Section 3020 of the New York City Charter;

WHEREAS, the Designation is subject to review by the Council pursuant to Section 3020 of the New York City Charter and Section 25-303 of the Administrative Code of the City of New York;

WHEREAS, the City Planning Commission submitted to the Council on January 15, 2021, its report on the Designation dated January 6, 2021 (the "Report");

WHEREAS, upon due notice, the Council held a public hearing on the Designation on January 20, 2021; and

WHEREAS, the Council has considered the land use implications and other policy issues relating to the Designation.
