A Local Law to amend the administrative code of the city of New York, in relation to defining the term selfclosing door

Be it enacted by the Council as follows:

Section 1. Subdivision a of section 27-2004 of the administrative code of the city of New York is

amended by adding a new paragraph 49 to read as follows:

49. The term "self-closing door" means a door equipped with a device that will ensure the door, when

opened and released, returns to the closed position and self-latches shut.

§ 2. This local law takes effect 45 days after it becomes law.
