WHEREAS, the New York City School Construction Authority submitted to the Council on December 10, 2009, a site plan dated December 10, 2009 pursuant to Section 1732 of the New York State Public Authorities Law for a new, approximately 612-Seat Primary/Intermediate School Facility, known as P.S. 281-Manhattan, to be located at on the east side of First Avenue between East 35<sup>th</sup> Street and East 36<sup>th</sup> Street (Block 967, Lot 1 in portion), Borough of Manhattan, Community Board No. 6, Borough of Manhattan, Community School District No. 2 (the "Site Plan");

WHEREAS, the Site Plan is subject to review and action by the Council pursuant to Section 1732 of the New York State Public Authorities Law;

WHEREAS, upon due notice, the Council held a public hearing on the Site Plan on December 15, 2009;

WHEREAS, the Council has considered the relevant environmental issues and the FSEIS issued on January 18, 2008 (CEQR Project Number 06DCPO39M); and
