A Local Law to amend the administrative code of the city of New York, in relation to waiving parks permit fees for schools and child day care centers and providing an online system for school permit applications

Be it enacted by the Council as follows:

Section 1. Chapter one of title 18 of the administrative code of the city of New York is amended by

adding a new section 18-158 to read as follows:

§18-158 Permit fee waiver for groups of children. a. Any school that provides educational instruction at

or below the twelfth grade level or any child day care center that applies for a permit for the use of any park

services under the jurisdiction of the commissioner shall not be required to pay any fee for such permit.

b. The commissioner shall provide a method for such schools and day care centers to apply for such

permits through the department's website for no charge.

§2. This local law shall take effect 90 days after it becomes law.
