Whereas, Bills have been introduced in the New York State Legislature by Senator Baileyg, S.9327, and Committee on Rules (Assembly Member Abbate), A.10360, "AN ACT to amend the retirement and social security law, in relation to allowing certain members of the New York city police pension fund to borrow from contributions"; *and*

Whereas, The enactment of the above State Legislation requires the concurrence of the Council of the City of New York as the local legislative body; *now, therefore, be it*
