**Whereas,** Bills have been introduced in the New York State Legislature by Senator Salazar, S.6726, and

Assembly Member Walker, A.6667, “AN ACT to amend chapter 548 of the laws of 2022 relating to authorizing the city of New York to discontinue the use as parkland a portion of real property in the borough of Brooklyn and to transfer such lands to the metropolitan transportation authority, to enable the New York city transit authority to construct in such areas new permanent at-grade station improvements and pedestrian bridges, in relation to making technical amendments thereto”; *and*
