WHEREAS, the Landmarks Preservation Commission filed with the Council on November 23, 2009 a copy of its designation dated November 10, 2009 (the "Designation"), of the E. Hayward and Amelia Parsons Ferry House located at 26 West 56 th Street, Community District 5, Borough of Manhattan, as a landmark and Tax Map Block 1271, Lot 54, as its landmark site pursuant to Section 3020 of the New York City Charter;

WHEREAS, the Designation is subject to review by the Council pursuant to Section 3020 of the City Charter;

WHEREAS, the City Planning Commission submitted to the Council on January 8, 2010 its report on the Designation dated January 6, 2010 (the "Report");
