Title: A Local Law to amend the administrative code of the city of New York, in relation to increasing the penalties for illegal powered mobility device sales, leases, or rentals, requiring that online sales of such devices include certification of accredited testing, imposing record keeping requirements on any person who distributes, sells, leases, rents, or offers to sell, lease or rent, any such devices, and, providing that the fire department have concurrent enforcement authority for violations of this section
