WHEREAS, the Landmarks Preservation Commission filed with the Council on February 19, 2010 a copy of its designation dated February 9, 2010 (the "Designation"), of the (Former) Yale Club of New York City Building (now Penn Club of New York), located at 30-32 West 44<sup>th</sup> Street, Community District 5, Borough of Manhattan, as a landmark and Tax Map Block 1259, Lot 54, as its landmark site pursuant to Section 3020 of the New York City Charter;

WHEREAS, the Designation is subject to review by the Council pursuant to Section 3020 of the City Charter;

WHEREAS, the City Planning Commission submitted to the Council on April 16, 2010 its report on the Designation dated April 14, 2010 (the "Report");

WHEREAS, upon due notice, the Council held a public hearing on the Designation on May 4, 2010; and

WHEREAS, the Council has considered the land use implications and other policy issues relating to the Designation;
