**Whereas,** bills have been introduced in the New York State Legislature by Senator Savino, S.6298-A, and Assembly Member Brook-Krasny, A.9478-A, "AN ACT to authorize the city of New York to discontinue the use as park-land of parcels of real property in the borough of Brooklyn in exchange for the dedication of certain other lands in the borough of Brooklyn for park purposes in furtherance of a comprehensive development plan for Coney Island"; and

**Whereas,** the enactment of the above State Legislation requires the concurrence of the Council of the
