Pursuant to Rule 10.60 of the Rules of the Council and Section 440 of the New York City Charter, the Committee on Rules, Privileges and Elections, hereby recommends the appointment by the Council of **Dr.**

Mohammad Khalid, a resident of Staten Island, as a member of the New York City Civilian Complaint Review Board to serve the remainder of a three-year term that expires on July 4, 2025.
