WHEREAS, the New York City School Construction Authority submitted to the Council on August 19, 2010, a site plan pursuant to Section 1732 of the New York State Public Authorities Law for a new, approximately 665-Seat Primary/Intermediate School Facility to be located at the southwest corner of 46<sup>th</sup> Avenue and 5<sup>th</sup> Street (Tax Map Block 21, Tax Map Lot 30 in portion), Community District 2, Borough of Queens, in Community School District No. 30 (the "Site Plan");

WHEREAS, the Site Plan is subject to review and action by the Council pursuant to Section 1732 of the New York State Public Authorities Law;

WHEREAS, upon due notice, the Council held a public hearing on the Site Plan on August 23, 2010;

WHEREAS, the Council has considered the relevant environmental issues and the Negative Declaration issued on August 18, 2010, (SEQR Project Number 11-001); and

WHEREAS, the Council has considered the land use implications and other policy issues relating to the Site Plan;
