WHEREAS, the Landmarks Preservation Commission filed with the Council on November 4, 2010 a copy of its designation dated October 26, 2010 (the "Designation"), of the Grace Episcopal Church Memorial Hall located at 155-24 90<sup>th</sup> Avenue, Community District 12, Borough of Queens as a landmark, and Tax Map Block 9754, Lot 7, as its landmark site pursuant to Section 3020 of the New York City Charter;

WHEREAS, the Designation is subject to review by the Council pursuant to Section 3020 of the City Charter;

WHEREAS, the City Planning Commission submitted to the Council on December 21, 2010 its report on the Designation dated December 15, 2010 (the "Report");

WHEREAS, upon due notice, the Council held a public hearing on the Designation on January 11, 2011; and

WHEREAS, the Council has considered the land use implications and other policy issues relating to the Designation;
