Resolution affirming the designation by the Landmarks Preservation Commission of the Japan Society Headquarters, located at 333 East 47<sup>th</sup> Street (Tax Map Block 1340, Lot 16), Borough of Manhattan, Designation List No. 440, LP-2420 (L.U. No. 403; 20115598 HKM; N 110278 HKM).

WHEREAS, the Landmarks Preservation Commission filed with the Council on March 29, 2011 a copy of its designation dated March 22, 2011 (the "Designation"), of the Japan Society Headquarters, located at 333 East 47<sup>th</sup> Street a.k.a. 327-333 East 47<sup>th</sup> Street, Community District 6, Borough of Manhattan as a landmark, and Tax Map Block 1340, Lot 16, as its landmark site pursuant to Section 3020 of the New York City Charter;

WHEREAS, the Designation is subject to review by the Council pursuant to Section 3020 of the City Charter;

WHEREAS, the City Planning Commission submitted to the Council on May 16, 2011, its report on the Designation dated May 11, 2011 (the "Report");

WHEREAS, upon due notice, the Council held a public hearing on the Designation on June 2, 2011; and

WHEREAS, the Council has considered the land use implications and other policy issues relating to the Designation;

**RESOLVED:**
