WHEREAS, the Department of Consumer Affairs filed with the Council on August 11, 2011 its approval dated August 11, 2011 of the petition of Super Noodle, Inc., d/b/a Old Town Hot Pot, for a revocable consent to establish, maintain and operate an unenclosed sidewalk café located at 70 Seventh Avenue, Community District 4, Borough of Manhattan (the "Petition"), pursuant to Section 20-226 of the New York City Administrative Code (the "Administrative Code");
