## THE COUNCIL OF THE CITY OF NEW YORK RESOLUTION NO. 1308

Resolution affirming the designation by the Landmarks Preservation Commission of the East 10<sup>th</sup> Street Historic District, Borough of Manhattan, Designation List No. 451, LP-2492 (L.U. No. 589; 20125456 HKM; N 120184 HKM).

WHEREAS, the Landmarks Preservation Commission filed with the Council on January 23, 2012 a copy of its designation dated January 17, 2012 (the "Designation"), of the East 10<sup>th</sup> Street Historic District, Community District 3, Borough of Manhattan.

The historic district boundaries consist of:

Properties bounded by a line beginning at the intersection of the northern curbline of East 10<sup>th</sup> Street and the eastern curbline of Avenue A, continuing northerly along the eastern curbline of Avenue A to its intersection with a line extending westerly from northern property line of 293 East 10<sup>th</sup> Street, easterly along the northern property line of 293 East 10<sup>th</sup> Street, northerly along a portion of the western property line of 295 East 10<sup>th</sup> Street, easterly along the northern property lines of 295 to 299 East 10<sup>th</sup> Street, southerly along a portion of the eastern property line of 299 East 10th Street, easterly along the northern property lines of 301 to 303 East 10th Street and a portion of the northern property line of 305 East 10<sup>th</sup> Street, northerly along a portion of the western property line of 305 East 10<sup>th</sup> Street, easterly along a portion of the northern property line of 305 East 10<sup>th</sup> Street and the northern property line of 307 East 10<sup>th</sup> Street, southerly along a portion of the eastern property line of 307 East 10<sup>th</sup> Street, easterly along the northern property line of 309 East 10<sup>th</sup> Street, southerly along a portion of the eastern property line of 309 East 10<sup>th</sup> Street, easterly along the northern property lines of 311 to 319 East 10<sup>th</sup> Street, southerly along a portion of the eastern property line of 319 East 10<sup>th</sup> Street, easterly along the northern property line of 321 East 10<sup>th</sup> Street, northerly along a portion of the western property line of 323 East 10<sup>th</sup> Street, easterly along the northern property lines of 323 to 339 East 10<sup>th</sup> Street, southerly along a portion of the eastern property line of 339 East 10<sup>th</sup> Street, easterly along the northern property lines of 341 to 345 East 10<sup>th</sup> Street to the western curbline of Avenue B, southerly along the western curbline of Avenue B to its intersection with the northern curbline of East 10<sup>th</sup> Street, westerly along the northern curbline of East 10<sup>th</sup> Street to the point of the beginning.

WHEREAS, the Designation is subject to review by the Council pursuant to Section 3020 of the City Charter;

WHEREAS, the City Planning Commission submitted to the Council on March 16, 2012 its report on the Designation dated March 14, 2012 (the "Report");

WHEREAS, upon due notice, the Council held a public hearing on the Designation on April 3, 2012;
