A Local Law in relation to naming eleven public thoroughfares and public places, Harold Rapkin Plaza, Borough of The Bronx, The Ramblersville-Hawtree Memorial Bridge, Borough of Queens, Donna and Michele Blanchard Plaza, Borough of Brooklyn, Arthur Hayes Way, Borough of Queens, Teddy White Place, Borough of Queens, John Downing Park, Borough of Queens, Boulevard of Bravery, Borough of Queens, Lawrence Virgilio Playground, Borough of Queens, Fred Wilson Way, Borough of Queens, Plaza of Heroes, Borough of Queens and Detective David Allen Way, Borough of Brooklyn.
