RESOLUTION NO. 23

Resolution approving an Urban Development Action Area Project located at Hopkinson Avenue between Dean and Bergen Streets, Bergen Street between Saratoga and Hopkinson Avenues, Bergen Street between Eastern Parkway and Mother Gaston Boulevard, Mother Gaston Boulevard between Dean and Bergen Streets, Hopkinson Avenue between Bergen Street and St. Mark's Avenue, St. Mark's Avenue between Hopkinson and Rockaway Avenues, Bergen Street between Hopkinson and Rockaway Avenues, St. Mark's Avenue between Hopkinson and Saratoga Avenues, Saratoga Avenue between St. Marks Avenue and Prospect Place, Prospect Place between Hopkinson and Saratoga Avenues (Block 1447/Lots 41-45 and 48; Block 1449/Lots 43, 47, part of 51, 62, 64-66, 68, 72-77; Block 1454/Lots 1, 4, 6, 9-12, part of 15, 16, 18, 21, 68, 70, 73, 75, 118 and 167; Block 1459/Lots 2-5, 7, 8, 10, 11, 21, 22, 69-71, 73-77, 79 and 82; Block 1464/Lots 12, 13 and 16-21; Brooklyn, and waiving the urban development action area designation requirement and the Uniform Land Use Review Procedure, pursuant to Sections 693 and 694 of the General Municipal Law (L.U. No. 35; 20025131 HAK).

WHEREAS, the New York City Department of Housing Preservation and Development ("HPD") submitted to the Council on December 10, 2001 its request dated November 28, 2001 that the Council take the following actions regarding the following Urban Development Action Area Project (the "Project") located at Hopkinson Avenue between Dean and Bergen Streets, Bergen Street between Saratoga and Hopkinson Avenues, Bergen Street between Eastern Parkway and Mother Gaston Boulevard, Mother Gaston Boulevard between Dean and Bergen Streets, Hopkinson Avenue between Bergen Street and St. Mark's Avenue, St. Mark's Avenue between Hopkinson and Rockaway Avenues, Bergen Street between Hopkinson and Rockaway Avenues, St. Mark's Avenue between Hopkinson and Saratoga Avenues, Saratoga Avenue between St. Marks Avenue and Prospect Place, Prospect Place between Hopkinson and Saratoga Avenues (Block 1447/Lots 41-45 and 48; Block 1449/Lots 43, 47, part of 51, 62, 64-66, 68, 72-77; Block 1454/Lots 1, 4, 6, 9-12, part of 15, 16, 18, 21, 68, 70, 73, 75, 118 and 167; Block 1459/Lots 2-5, 7, 8, 10, 11, 21, 22, 69-71, 73-77, 79 and 82; Block 1464/Lots 12, 13 and 16-21; Borough of Brooklyn (the "Project Area")):

1. Find that the present status of the Project Area tends to impair or arrest the sound growth and development of the municipality and that the proposed Urban Development Action Area Project is consistent with the policy and purposes stated in Section 691 of the General Municipal Law;

- 2. Waive the area designation requirement of Section 693 of the General Municipal Law pursuant to said Section;
- 3. Waive the requirements of Sections 197-c and 197-d of the New York City Charter pursuant to Section 694 of the General Municipal Law;
- 4. Approve the Project as an Urban Development Action Area Project pursuant to Section 694 of the General Municipal Law; and
- 5. Approve the exemption of the Project from real property taxes pursuant to Section 696 of the General Municipal Law (the "Tax Exemption").

WHEREAS, the Project is to be developed on land that is now a municipally-owned area as defined in Section 692 of the General Municipal Law, consists solely of the rehabilitation or conservation of existing private or multiple dwellings or the construction of one to four unit dwellings, and does not require any change in land use permitted under the New York City Zoning Resolution;

WHEREAS, upon due notice, the Council held a public hearing on the Project on January 25, 2002;

WHEREAS, the Council has considered the land use, environmental and financial implications and other policy issues relating to the Project;

RESOLVED:

The Council finds that the project described herein will have no significant effect on the environment.

The Council finds that the present status of the Project Area tends to impair or arrest the sound growth and development of the City of New York and that a designation of the Project as an urban development action area project is consistent with the policy and purposes stated in Section 691 of the General Municipal Law.

The Council waives the area designation requirement of the Area as an urban development action area under Section 693 of the General Municipal Law.

The Council waives the requirements of Sections 197-c and 197-d of the New York City Charter pursuant to Section 694 of the General Municipal Law.

The Council approves the Project as an urban development action area project pursuant to Section 694 of the General Municipal Law.

The Project shall be developed in a manner consistent with the Project Summary that HPD has submitted to the Council, a copy of which is attached hereto.

The exemption of the Project from real property taxes pursuant to Section 696 of the General Municipal Law is approved as follows:

- a. All of the value of the buildings, structures, and other improvements situated on the Project Area shall be exempt from local and municipal taxes, other than assessments for local improvements and land value, for a period of twenty years commencing on the July 1st following the conveyance of the Disposition Area to the Sponsor, during the last ten years of which such exemption shall decrease in equal annual decrements.
- b. The partial tax exemption granted hereunder shall terminate with respect to all or any portion of the Project Area if the Department of Housing Preservation and Development determines that such real property has not been, or is not being, developed, used, and/or operated in compliance with the requirements of all applicable agreements made by the Sponsor or the owner of such real property with, or for the benefit of, the City of New York. The Department of Housing Preservation and Development shall deliver written notice of any such determination of noncompliance to the owner of such real property and all mortgagees of record, which notice shall provide for an opportunity to cure of not less than ninety (90) days. If the noncompliance specified in such notice is not cured within the time period specified therein, the partial tax exemption granted hereunder shall prospectively terminate with respect to the real property specified therein.
