THE COUNCIL OF THE CITY OF NEW YORK RESOLUTION NO. 1152

Resolution approving an Urban Development Action Area Project located at 1185 Fulton Avenue (Block 2609/Lot 43), the Bronx, and waiving the urban development action area designation requirement and the Uniform Land Use Review Procedure, pursuant to Sections 693 and 694 of the General Municipal Law (L.U. No. 555; 20045220 HAX).

WHEREAS, the New York City Department of Housing Preservation and Development ("HPD") submitted to the Council on September 26, 2003 its request dated September 8, 2003 that the Council take the following actions regarding the following Urban Development Action Area Project (the "Project") located at 1185 Fulton Avenue (Block 2609/Lot 43), Community District 3, Borough of the Bronx (the "Disposition Area"):

- 1. Find that the present status of the Disposition Area tends to impair or arrest the sound growth and development of the municipality and that the proposed Urban Development Action Area Project is consistent with the policy and purposes stated in Section 691 of the General Municipal Law;
 - 2. Waive the area designation requirement of Section 693 of the General Municipal Law pursuant to said Section;
- 3. Waive the requirements of Sections 197-c and 197-d of the New York City Charter pursuant to Section 694 of the General Municipal Law;
- 4. Approve the Project as an Urban Development Action Area Project pursuant to Section 694 of the General Municipal Law; and
- 5. Approve a partial exemption of the Project from real property taxes pursuant to Section 577 of Article XI of the Private Housing Finance Law (the "Tax Exemption");

WHEREAS, the Project is to be developed on land that is now a municipally-owned area as defined in Section 692 of the General Municipal Law, consists solely of the rehabilitation or conservation of existing private or multiple dwellings or the construction of one- to four-unit dwellings, and does not require any change in land use permitted under the New York City Zoning Resolution;

WHEREAS, the project description that HPD provided to the Council states that the purchaser in connection with the Sale (the "Sponsor") is a duly organized housing development fund company under Article XI of the Private Housing Finance Law;

WHEREAS, upon due notice, the Council held a public hearing on the Project on November 6, 2003;

WHEREAS, the Council has considered the land use and financial implications and other policy issues relating to the Project;

RESOLVED:

The Council finds that the present status of the Disposition Area tends to impair or arrest the sound growth and development of the City of New York and that a designation of the Project as an urban development action area project is consistent with the policy and purposes stated in Section 691 of the General Municipal Law.

The Council waives the area designation requirement of the Disposition Area as an urban development action area under Section 693 of the General Municipal Law pursuant to said Section.

The Council waives the requirements of Sections 197-c and 197-d of the New York City Charter pursuant to Section 694 of the

Sponsor shall make such partial annual real estate tax payment on essed valuation equal to the lesser of (i) an amount equal to the full assessed valuation of the Residential Property, or (ii) an amount atted by multiplying \$3500 times the number of residential units included in the housing project and increasing such product by six percent July 1, 1990 and July 1 of each successive year, but not by more than twenty percent (20%) in any five-year period.
