THE COUNCIL OF THE CITY OF NEW YORK  
RESOLUTION NO. 1587

Resolution approving the decision of the City Planning Commission on ULURP No. C 080371 ZMQ, a Zoning Map change (L.U. No. 820).

WHEREAS, the City Planning Commission filed with the Council on July 25, 2008 its decision dated July 23, 2008 (the "Decision"), on the application submitted by the Department of City Planning, pursuant to Sections 197-c and 201 of the New York City Charter, for an amendment to the Zoning Map (ULURP No. C 080371 ZMQ) (the "Application");

WHEREAS, the Application is related to Applications Numbers N 080372 ZRQ to modify Section 21-12 of the New York City Zoning Resolution to allow designation of an R2X district and N 080373 ZRQ to modify Section 25-00 of the New York City Zoning Resolution to apply the accessory off-street parking regulations of an R5 district to R6 and R7 districts within Queens, Community District 14 (L.U. No. 824);

WHEREAS, the Decision is subject to review and action by the Council pursuant to Section 197-d(b)(1) of the City Charter;

WHEREAS, upon due notice, the Council held a public hearing on the Decision and Application on August 12, 2008;

WHEREAS, the Council has considered the land use implications and other policy issues relating to the Decision and Application; and

WHEREAS, the Council has considered the relevant environmental issues and the Negative Declaration, issued on April 21, 2008, which included (E) designations for hazardous materials (CEQR No. 08DCP065Q);

RESOLVED:

The Council finds that the action described herein will have no significant effect on the environment.

Pursuant to Sections 197-d and 200 of the City Charter and on the basis of the Decision and Application, the Council approves the Decision.

The Zoning Resolution of the City of New York, effective as of December 15, 1961, and as subsequently amended, is further amended by changing the Zoning Map, Section Nos. 25b, 30a, 30b, 30c, 31a:

  - b. a line 100 feet northwesterly of Rockaway Beach Boulevard, Beach 109<sup>th</sup> Street, Rockaway Beach Boulevard, and a line 365 feet southwesterly of Beach 109<sup>th</sup> Street;
  - c. Rockaway Beach Boulevard, Beach 108<sup>th</sup> Street, a line 150 feet southeasterly of Rockaway Beach Drive, and Beach 109<sup>th</sup> Street;
  - d. a line 150 feet northwesterly of Rockaway Beach Boulevard, Beach 101<sup>st</sup> Street, a line 150 feet southeasterly of Rockaway Beach Boulevard, and Beach 102<sup>nd</sup> Street; and
  - e. Beach Channel Drive, Beach 66<sup>th</sup> Street, a line 100 feet southerly of Beach Channel Drive, and Beach 67<sup>th</sup> Street;
3. eliminating from within an existing R6 District a C1-2 District bounded by Rockaway Beach Boulevard, Beach 90<sup>th</sup> Street, a line 150 feet southeasterly of Rockaway Beach Boulevard, and Beach 91<sup>st</sup> Street;
4. eliminating from within an existing R4 District a C2-2 District bounded by:
  - a. Beach Channel Drive, a line midway between Beach 102<sup>nd</sup> Street and Beach 101<sup>st</sup> Street, the centerline of a railroad right-of-way, and Seaside Avenue;
  - b. the U.S. Bulkhead Line, a line 1110 feet northeasterly of Beach 92<sup>nd</sup> Street, Beach Channel Drive, and Beach 92<sup>nd</sup> Street; and
  - c. a line 100 feet northwesterly of Beach Channel Drive, Beach 59<sup>th</sup> Street, Beach Channel Drive, and Beach 61<sup>st</sup> Street;
5. eliminating from within an existing R5 District, a C2-2 District bounded by:
  - a. a line 100 feet northwesterly of Rockaway Beach Boulevard, the northwesterly prolongation of the southwesterly street line of Beach 111<sup>th</sup> Street, Rockaway Beach Boulevard, and the

- northwesterly prolongation of the northeasterly street line of Beach 114<sup>th</sup> Street; and
- b. Rockaway Freeway, Beach 102<sup>nd</sup> Street, Rockaway Beach Boulevard, and Beach 108<sup>th</sup> Street;
6. eliminating from within an existing R6 District a C2-2 District bounded by a line 150 feet northwesterly and northerly of Rockaway Beach Boulevard, Beach 86<sup>th</sup> Street, Rockaway Beach Boulevard, and Beach 91<sup>st</sup> Street;
  7. eliminating from within an existing R4 District a C2-4 District bounded by:
    - a. Rockaway Beach Boulevard, the centerline of former Beach 43<sup>rd</sup> Street, a line 85 feet northerly of the Shorefront Parkway, and Beach 47<sup>th</sup> Street; and
    - b. Beach Channel Drive, Beach 35<sup>th</sup> Street, the northeasterly centerline prolongation of Rockaway Beach Boulevard, and Beach 36<sup>th</sup> Street;
  8. eliminating from within an existing R6 District a C2-4 District bounded by:
    - a. the northeasterly centerline prolongation of Rockaway Beach Boulevard, Beach 35<sup>th</sup> Street, Shore Front Parkway, the southerly centerline prolongation of Beach 36<sup>th</sup> Street; and
    - b. a line 100 feet southeasterly of Shore Front Parkway, Beach 35<sup>th</sup> Street, Ocean Front Road, the southerly prolongation of the centerline of Beach 36<sup>th</sup> Street, a line 100 feet northerly of Ocean Front Road, and a line 100 feet westerly of Beach 35<sup>th</sup> Street;
  9. changing from an R2 District to an R2X District property bounded by a boundary line of the City of New York, a line 100 feet southeasterly of Hicksville Road, Reads Lane, Hicksville Road, Beach 9<sup>th</sup> Street, and Empire Avenue;
  10. changing from an R5 District to an R3A District property bounded by a line 100 feet southeasterly of Rockaway Beach Drive, Beach 108<sup>th</sup> Street, a line 120 feet northwesterly of Rockaway Park and its northeasterly prolongation, a northwesterly boundary line of Rockaway Park, a line 100 feet southwesterly of 109<sup>th</sup> Street, a line 260 feet northwesterly of Rockaway Park, and Beach 109<sup>th</sup> Street;

20. changing from an R3-2 District to an R4-1 District property bounded by a U.S. Pierhead and Bulkhead Line, the westerly centerline prolongation of Alameda Avenue, a line 200 feet easterly of a proposed U.S. Pierhead and Bulkhead Line, a line 100 feet northerly of a proposed U.S. Pierhead and Bulkhead Line, the southerly prolongation of a westerly boundary line of a proposed U.S. Pierhead and Bulkhead Line, Parvine Avenue, Beach 61<sup>st</sup> Street, a line 100 feet northwesterly and northerly of Beach Channel Drive, a line midway between Beach 66<sup>th</sup> Street and Beach 67<sup>th</sup> Street, and Alameda Avenue;
